Federal law requires financial institutions to obtain, verify, and record personal information for all account holders. This measure helps the government combat terrorism funding and money laundering activities.

For personal accounts, we will request your name, address, date of birth, and other identifying information. You may be asked to provide your driver's license or other documents.

For legal entity accounts, we must identify beneficial owners and controlling persons.
